- **Insurance:** Insurance policies were renewed with HUB International.
- Audits: The Department of Economic Development (DCED) and the State Workers Insurance Fund (SWIF) both require annual audits of the Authority's records and financial statements from the previous year.
 - DCED Audit: McGill, Power, Bell & Associates will conduct the audit and will be invited to the October meeting to present their findings.
 - SWIF Audit: The audit was conducted within the month following the February 14 renewal.
- Commissioners Meeting: The Executive Director attended the Commissioners meeting to request that Brenda Schmidt be appointed as the Crawford County Recycling Coordinator and to seek permission to apply for the 903 County Recycling Coordinator Reimbursement Grant from the DEP on the County's behalf. Both requests were approved. *Beginning this year, we will be seeking these approvals in December of the prior year.

Grants/Annual Report

- o **902 Grant Education Campaign:** Work is on-going with Starn Marketing.
- 903 Grant: The recycling coordinator grant application for calendar year 2022 was submitted by the April deadline.
- 2022 Calendar Year Act 101 Annual Report: The report was completed and submitted on time.
- Latest 902 Grant Application: Award information is expected to be released by the end of June.

- **Education Programs:** Authority staff will be providing educational programs throughout the summer and into the Fall.
- County Solid Waste Plan Update: Brenda Schmidt will provide an update. The plan timeline is on-schedule.
- 2024 Budget: A draft copy of the 2024 budget will be presented for review. The budget
 meetings with the Commissioners will likely be held prior to the Authority's October
 meeting.
- **Tech Issues:** Starlink has been installed. Monthly service fees will be \$105, however, the AT&T service fee will be reduced to reflect the change in service.
- **Special Collections:** The Authority has contracted with Noble Environmental for the collection of HHW and e-Waste.
