- Insurance: Insurance policies were renewed with HUB International.
   The Crime Prevention Policy has been cancelled/terminated. Our agent was able to include the coverage in our General Liability policy. See attached letter.
- Audits: The Department of Economic Development (DCED) and the State Workers Insurance Fund (SWIF) both require annual audits of the Authority's records and financial statements from the previous year.
  - DCED Audit: McGill, Power, Bell & Associates will conduct the audit and will be invited to the October meeting to present their findings.
  - SWIF Audit: The audit was conducted within the month following the February 14 renewal.

## Grants/Annual Report

- o **902 Grant Education Campaign:** Work is on-going with Starn Marketing.
- 903 Grant: The recycling coordinator grant application for calendar year 2023 was submitted by the May 1st deadline.
- 2023 Calendar Year Act 101 Annual Report: The report was completed and submitted on time.
- o Latest 902 Grant Application: We are not eligible for this round.
- **Education Programs:** Authority staff will be providing educational programs throughout the summer and into the Fall.
- County Solid Waste Plan Update: The plan timeline is on-schedule.

- PROP Conference: The state recycling conference will be held July 24-26 in Bethlehem, PA. Total estimated expenses are approximately \$2,100. The 903 grant covers 50% of Lancaster, approved expenses and \$5,000 was budgeted for Professional Development. Although budgeted in 2023, the Executive Director did not attend the PROP Conference.
- Resource Recycling Conference: The national recycling conference will be held November 13-15 in Louisville, KY. Registration information is not available currently. Estimated expenses would be \$6,000. The Director will seek travel approval from DEP so that the expenses will be eligible for 50% reimbursement.
